Eligible Entrants must be able to attend the Women's Final to accept their prize. |

| Entry Procedure | To enter, Eligible Entrants must, during the Promotion Period, purchase a ticket(s) to the ICC Women's T20 World Cup Final on 8 th March 2020 at the Melbourne Cricket Ground (MCG) (Women's Final) online through www.tickets.t20worldcup.com (the Website). Once an Eligible Entrant has purchased a ticket(s) to the Women's Final, they will be sent a link in the ticket confirmation email to an entry form for this Promotion, which they must complete to enter. In addition, any Eligible Entrants who purchased tickets to the Women's Final online via the Website prior to the commencement of the Promotion Period will be sent a link to the entry form, which must be completed to enter into the Promotion. Eligible Entrants may purchase a maximum of 8 tickets to the Women's Final in any one transaction. The winning ballot entries (Winner) will be drawn at random and determined by chance. Skill plays no part in determining the winners. Winners will be allocated one access pass for on-field access per person for the number of passes requested in the entry form completed as part of the Winner's entry (Pass Holder) (as determined by the Promoter in its sole discretion and until all passes are allocated). First up

1. These terms and the Schedule form the Conditions of Entry for this Promotion, and set out all of the information you need to know regarding this Promotion. Capitalised terms have the meaning given in the Schedule, unless otherwise stated. If there's any inconsistency between these terms and the Schedule, then what's in the Schedule is correct. By submitting your entry, you agree that these Conditions of Entry apply to your entry.
2. The promoter is T20 World Cup 2020 Ltd ABN 14 618 113 269, of Level 2, 128 Jolimont Road, Jolimont, Victoria, 3002 ('**Promoter**', '**we**', '**us**').
3. Any updates to these Conditions of Entry will be subject to regulatory approval, and will be published on the website www.cricket.com.au/competitions, so it's important to check these Conditions of Entry regularly.

Who can enter ... and who can't

4. The eligibility requirements for this Promotion are set out in the Entry Restrictions. Directors, managers, employees, officers, agents and contractors of the Promoter, and their immediate families (ie spouse, partner, parent, grandparent, natural or adopted child, and sibling (whether natural or adopted by a parent)) are ineligible to enter.

How to enter

6. We will not accept entries which are incomplete, illegible, or which are generated by computers or other automated means.
