By submitting your entry, you agree that these Conditions of Entry apply to your entry.
2. The promoter is Cricket Australia (ABN 53 006 089 130), of 60 Jolimont Street, Jolimont, Victoria, 3002 ('**Promoter**', '**we**', '**us**').

#### Who can enter ... and who can't
