Capitalised terms have the meaning given in the Schedule, unless otherwise stated. If there's any inconsistency between these terms and the Schedule, then what's in the Schedule is correct. By submitting your entry, you agree that these Conditions of Entry apply to your entry.
2. The promoter is Cricket Australia (ABN 53 006 089 130), of 60 Jolimont Street, Jolimont, Victoria, 3002 (**'Promoter', 'we', 'us'**).
3. Any updates to these Conditions of Entry will be published on our website [www.cricket.com.au/competitions](http://www.cricket.com.au/competitions), so it's important to check these Conditions of Entry regularly.

#### Who can enter ... and who can't

4. The eligibility requirements for this Promotion are set out in the Entry Restrictions. Directors, managers, employees, officers, agents and contractors of the Promoter, and their immediate families (ie spouse, partner, parent, grandparent, natural or adopted child, and sibling (whether natural or adopted by a parent)) are ineligible to enter.

#### How to enter

5. To enter, you must follow the Entry Procedure.
6. We will not accept entries which are incomplete, illegible, or which are generated by computers or other automated means.
7. We reserve the right to disqualify your entry in the event of non-compliance with these Conditions of Entry or if, in our reasonable opinion, you tamper or interfere with an entry mechanism in any way.
8. If the Promotion cannot run for reasons beyond our control (for example, infection by computer virus, mobile network failure, bugs, tampering, unauthorised intervention, fraud, or technical failures), we reserve the right to cancel, suspend, modify or terminate the Promotion. #### Rules about entry content

10. Where relevant, you must take full responsibility for the content of your entry and for ensuring that your entry complies with these Conditions of Entry.
