Entry Restrictions	Entry is open to residents of Australia aged 13 years or older at the commencement of the Promotion (Eligible Entrants). Eligible Entrants less than 18 years of age must have the consent of their parent or guardian in order to enter and must be accompanied by a parent or guardian who is a ticket holder and prize winner. By entering this Promotion, Eligible Entrants confirm that they have consent, and the Promoter reserves the right to verify this. Eligible Entrants must be able to attend the match for which they have purchased their ticket to accept their prize.
Verification Requirements	The entrant agrees and acknowledges that they have read these Terms and Conditions and that entry into the Promotion is deemed to be acceptance of these Terms and Conditions.
Entry Procedure	To enter, Eligible Entrants must, during the Promotion Period purchase tickets to the Gabba Test match online through www.ticketmaster.com.au and enter the offer code word "Pool" during the promotional period. Transaction limit is a maximum of 9 tickets per day of cricket applies, with each transaction qualifying as one entry into the draw. Valid and eligible entries will be accepted up to 8.59AM AEDT on Thursday 1st December, 2016. If the prize(s) is won by a person under the age of 18, the prize may be awarded to the winner's parent or guardian and where applicable to the prize, a parent or guardian must accompany any person under 18 years of age. The prize will be drawn at 10:00AM AEDT on Monday December 5th, with winners notified by email. Winners will be drawn until all prizes are allocated. The winner of a drawn prize is determined by chance. Skill plays no part in determining the winner. Total of 40 pool deck passes are available across two sessions (Session 1 from 1:00pm – 4:20pm and Session 2 from 4:40pm to end of play) each day (Days 1, 2, 3 and 4) of the Gabba Test match (December 15-18). First up

1. These terms and the Schedule form the Conditions of Entry for this Promotion, and set out all of the information you need to know regarding this Promotion. Capitalised terms have the meaning given in the Schedule, unless otherwise stated. If there's any inconsistency between these terms and the Schedule, then what's in the Schedule is correct. By submitting your entry, you agree that these Conditions of Entry apply to your entry.
2. The promoter is Cricket Australia (ABN 53 006 089 130), of 60 Jolimont Street, Jolimont, Victoria, 3002 ('**Promoter**', '**we**', '**us**').
3. Any updates to these Conditions of Entry will be subject to regulatory approval, and will be published on our website www.cricket.com.au/competitions, so it's important to check these Conditions of Entry regularly.

Who can enter ... and who can't
